QUANTITY – You are bidding a “per unit” price for ONE Unit. Bids shall be valid for 60 days after bid submission.

PAYMENT – Payment shall be made within 45 days of receipt of invoice.

EQUIPMENT PROPOSALS

The Meridian Airport Authority will receive Equipment Proposals (no price) for the unit specified herein on or before 2:00 p.m. Central Standard Time on Friday, **February 7, 2023** at the Central Bidding website. Since these proposals are not priced, they are not considered sealed or confidential and early submission is encouraged to allow more time for review. These proposals shall adequately identify the specific equipment you wish to bid and that you (the vendor) and the equipment meet the specifications contained herein. Additionally, equipment proposal shall include your delivery schedule from date of bid award. If your proposal is acceptable, we will contact you using your submitted contact information prior to 5 PM on **February 9, 2023** Central Standard Time and invite you to submit a bid price as described in the “Bid Price Submittal” section.

BID PRICE SUBMITTAL

Bidding will be held by electronic reverse auction on **February 10, 2023** at www.centralbidding.com beginning at 10:00 a.m. and ending at 10:30 a.m. Central Standard Time (unless extended by anti-sniping).

The Authority may utilize “anti-sniping” for reverse auctions. Anti-sniping is a tool that automatically extends the bid time for reverse auction by five (5) minutes if a vendor places a bid in the final five (5) minutes of the reverse auction. The anti-sniping effect will auto extend the reverse auction bid time any time a bid is placed in the last five (5) minutes of the reverse auction and can auto extend the reverse auction multiple times until the bidding on the reverse auction ends.
